





# Historical and Projected Bankruptcy Case Filings in USTP Districts in Thousands



#### **2023 MONTHLY FILING TOTALS**




2023 YTD total filings are **up 17.64%** compared to the same time period in 2022. This total is **40.33% below** the pre-Covid average\* for January – December.



#### **2023 MONTHLY CHAPTER 7 FILINGS**




2023 YTD Chapter 7s are **up 15.60%** compared to the same time period in 2022. This total is **47.10% below** the pre-Covid average\* for January – December.



#### **2023 MONTHLY CHAPTER 13 FILINGS**




2023 YTD Chapter 13s are **up 19.28%** compared to the same time period in 2022. This total is **32.99% below** the pre-Covid average\* for January – December.



#### **2023 MONTHLY CHAPTER 11 FILINGS**




2023 YTD Chapter 11s are **up 69.06%** compared to the same time period in 2022. This total is **16.37% above** the pre-Covid average\* for January – December.




#### **BANKRUPTCY FILINGS BY REGION**
